Releasing Examination Information in relation to COVID-19



A lot of schools are contacting us regarding **Data Protection** in the light of the Ofqual proposed **revised system** for **awarding grades** in public examinations in the light of Covid-19.

We have put together a briefing note to help you with this as far as is possible so far. Proposals have **not** yet been finalised and since the consultation ended on the **29th April** this may take a while. If things change, we will publish an update.

The issue from a **Data Protection perspective** is how schools should deal with a **Subject Access Request** or **Freedom of Information request** in relation to exam rankings and gradings.

Our **full current** advice can be found via the [link](#). We know there is a lot to it but it should help you in deciding **what to do** if you have a difficulty.

Some key points are:

- Remind staff of whom they should contact if they receive a request from a student or parent asking for **personal information** about **individuals** including students, especially one relating to the examinations process.
- When writing **emails** or **any form** of written correspondence remind staff that, as always, they should:
 - Record information in a way that they would **feel comfortable** releasing to the student or their parents.
 - Delete drafts once they are no longer **needed**.
 - Retain emails in accordance with the School's **retention policy** and **save them** to the appropriate folder.
 - Communicate **only** via the school's **official channels**. Staff should not be tempted to discuss students via Whatsapp, personal emails or texts on personal devices etc. If **not** adhered to this could result in personal devices or accounts being **liable to be searched** in the event of a subject access request.

Of special importance, requests for **minutes of meetings** around the way in which students will be graded or ranked, could be requested under Freedom of Information legislation.

Ofqual advise from their perspective this should **not** be released to the student or parents.

In relation to **Data protection legislation** it is possible that the information may fall within an **exemption** and thus **not** have to be released, but this needs to be carefully considered on a **case by case** basis. We can help with that.

We do not advise schools as **standard** on Freedom of Information, but because of circumstances and understanding the difficulty this might cause you, we **will** help you consider requests where they relate to release of examinations information, but a modest charge may apply.

We appreciate this is a complicated area so hope this helps!
